Can you rent out a vacant land?

What is ground rent?

Leasehold is a right that gives the leaseholder the authority to use someone else's land. The owner of the land remains the municipality or a private individual, but the leaseholder has the enjoyment of the land and may, for example, build a house on it.

Can you rent out vacant land?

Renting out vacant land is a practice that has been in use for centuries and offers ample opportunities to make money. You can rent vacant land in two ways: By developing the land or by renting the vacant, raw land.

How does a ground lease work?

A lease agreement between two parties gives a right to use the land on which your home is built. An annual fee for a ground lease is paid to a city or private landlord. The tenant has the right to use and develop the land during the lease period, but the landlord retains ownership of the land.
