What does NDRC & Nea's energy reform mean for investors?

The reform aims to enhance competition but raises uncertainty over future returns for investors. China's National Development and Reform Commission (NDRC) and the National Energy Administration (NEA) have issued a directive to accelerate market-based pricing for renewable energy, including wind and solar power.

Will the NDRC switch to a market-based bidding system?

Will NDRC and Nea change electricity prices?

According to South China Morning Post, NDRC and NEA have instructed local governments to develop their own market-oriented price plans by the end of the year. However, officials found it reasonable that the change did not have a significant impact on electricity prices for residential users, farmers or most businesses.

How will China's solar subsidies affect the solar industry?

The reduction in subsidies could place additional strain on China's solar industry, which is already grappling with overcapacity and plummeting panel prices that threaten the viability of smaller manufacturers.

How will grid connection pricing change in 2025?

Projects can either submit bids for pricing and output or accept the prevailing market rate. For projects commissioned before June 2025, the transition will follow a price-difference settlement mechanism, aligning grid connection pricing with current policy.
